TASKS TO BE PERFORMED BY THE TRACKING COMPANY:

- 1. To provide tracking devices and tracking services of 20 Excavators and 9 Loaders.
- 2. To coordinate the matters/affairs with authorized officer of PASDEC.
- 3. Firm will be responsible for successful installation, testing and troubleshooting of the tracking system.
- 4. Firm will impart training to PASDEC officials for monitoring of tracking services.
- 5. Installation of trackers will be completed in one month [30 days] from the date of award of contract.
- 6. Troubleshooting will be ensured within 3 hours.
- 7. Firm will provide insurance/warranty of all tracking system/equipment for the period of contract agreement.
- 8. Tracking System must include and capable of following features;
 - 24/7 tracking report of operations
 - Timing and location of machines
 - Operational hours of each machine
 - Different alerts automatically pop up
 - Operations report for department review and office record on daily/weekly/monthly/yearly basis
 - Complete data access to the PASDEC officials over dedicated online portal including real time monitoring facility of working/moving/stationed machines
 - Mobile application for the tracking system [if any]
 - Text message alerts
 - Remotely engine locking
 - Battery interruptions report
 - Tracking device interruption tampering/in connection alert
 - Data backup must be made available for at least 6 months
